Basis of Rates:

All prices are based on two persons sharing a cabin or a single where noted. All prices and fares are quoted in U.S. dollars.

Single Occupancy

Traveling solo? We can arrange for you to share a cabin with a shipmate of the same gender. If you prefer a cabin to yourself, supplement for single occupancy is 75% above the double occupancy fare.

We reserve the right to limit the number of Single Supplement cabins sold per sailing. Black out dates and restrictions and holiday surcharges may apply.

Costs Include:

Cruise prices include all on board meals and snacks, wine with dinner, educational lectures, use of the ship's fitness center, access to the ship's library, Zodiac transfers, use of snorkeling equipment and kayaks.
